

## Temporary Accommodation Application Form

STUCCO Student Housing Coop provides short-term accommodation for full time, domestic or international, students that are without a place to live. If you have just moved to Sydney from a different city, been kicked out of home by your parents, landlord, bad housemates or because of financial difficulties, STUCCO *may* be able to give you a home for two weeks -with possible extensions - while you get back on your feet. Stucco has a gregarious atmosphere and new faces are always welcome. # Terms and Conditions of Temporary Accommodation at STUCCO

1. Temporary Accommodation is offered at STUCCO to full-time, domestic or international University of Sydney students for 2 weeks with the *possibility* of an extension upon review. A Temporary Accommodation Guest (TAG) can stay for a maximum of 6 weeks at STUCCO, provided extensions are granted. After 6 weeks, a TAG must move out of the cooperative regardless of whether or not they have found permanent accommodation.
2. A Temporary placement at STUCCO is offered both by the co-operative and by individual households, and STUCCO reserves the right to refuse an application for Temporary Accommodation if a) there are no Temporary rooms available; and b) a room is available, but for whatever reason, a household does not wish for this room to be occupied. If a room is available and a household agrees to the placement of a Temporary applicant in their unit then Temporary Accommodation will be granted on the terms described above and below.
3. If Temporary Accommodation is granted, the applicant will agree to meetings with the Temporary Accommodation Officer(s) at 2 week intervals for the period of their stay.
4. Temporary Accommodation Guests are required to be actively looking for alternate permanent accommodation for the duration of their stay at STUCCO. Applying for STUCCO accommodation does not count as looking for alternative permanent accommodation and will not be considered by Temporary Accommodation Officers as a Temporary Accommodation Guest having fulfilled their requirement to look for permanent accommodation.
5. STUCCO offers only Temporary Accommodation and not crisis accommodation or any other form of crisis support.
6. Due to the lack of appropriate resources at STUCCO to deal with crisis situations, STUCCO reserves the right to ask persons in Temporary Accommodation to vacate with 24 hours informal notice in extenuating circumstances. This notice would be given in the event that a person in Temporary Accommodation poses a threat of injury, both to themselves and others within STUCCO. The definition of injury in this context is broad and encompasses a threat of injury to the emotional, mental or physical well-being of both the temporary recipient of Temporary Accommodation, current members and their guests.
7. STUCCO reserves the right to ask persons in Temporary Accommodation to vacate the premises with 24 hours notice if any circumstances of misconduct come to light, including but not limited to the theft or misuse of STUCCO property and resources, or the theft and misuse of the property of STUCCO members. **Temporary Accommodation Guests therefore need to make sure they have alternate emergency accommodation arranged in the event that they are asked to vacate the premises within 24 hours.**
8. Temporary Accommodation Guests will not be given keys to the premises
9. STUCCO abides by a safe space policy; meaning that we do not tolerate any form of harassment, oppression, offensive language, and discrimination towards ableism, ageism, transphobia, homophobia, and sexism to name a few. Any form of prejudice towards people's race/ethnicity, sexual orientation, gender identity, cultural backgrounds, class, language ability, or religious affiliation is likewise not accepted. We furthermore strive to be respectful of people's physical and emotional space and as such, operate on consensual-based interaction at all times. Stucco prides itself on fostering an environment whereby members and guests alike feel respected and safe. As such, any breach of our safe space policy is taken very seriously and can result in a Temporary Accommodation Guest being asked to vacate the premises.
